The following are a few tips to keep in mind immediately after involvement in a collision: Shift your vehicle into "park." Check yourself and any passengers for injuries. If you cannot move your vehicle, or if medical assistance is needed, dial "911" and follow the operator's instructions. If your vehicle is operable, and neither you nor any passengers with you have suffered any injuries, you should move to a secure location (such as the nearest shoulder, the median, or the rightmost lane of the road) before exiting to assess the situation. Doing so will: Protect you from oncoming traffic. Allow safer passage for other motorists on the road. Provide easier access for emergency responders to reach you, if necessary.
